# FINANCIAL INFORMATION

## IMPORTANT FEE INFORMATION

- Any application or admittance to the school will be considered incomplete until the necessary fees have been received.
- CDIS prefers that payments of 5,000 RMB or more be made by wire transfer.
- All telegraphic transfer (TT) fees, including domestic and international transfer fees, must be charged to your account and not taken out of school tuition. The Finance Office should be notified within five business days of the transfer or else the payment cannot be credited. The transfer receipt may be mailed or delivered to the CDIS Finance Office.
- Student's passport name(s) and invoice number must be written in the Bank Transfer.
- All tuition and fees are based on the RMB amount. The RMB fee will not change. In the event of changes in the exchange rate for all the unpaid tuition, you may contact the Finance Office to get the current rate.
- The enrollment fee is due **before** each student's first day of school. Tuition is due on the student's first day of school.
- **SOCIAL INSURANCE SURCHARGE:** In the event that CDIS is required to pay into the Chinese social insurance program, a surcharge of approximately ¥6,000 per student will be applied.

## LATE FEE

- Tuition payments are due according to the payment schedule **shown on your school invoice**.
- Payment more than **5 business days past due** incurs a **¥ 50 late fee per business day**.
- Payment more than **30 days past due** incurs a **¥50 late fee per business day** and student may be excluded from classes until payment is made. Report cards and transcripts will be withheld.

## PARTIAL YEAR TUITION AND FEES

- If a student applies and is accepted into the school after the beginning of the semester, tuition and fees will be charged by the half quarter.
- Student who graduates at the end of the first semester will be required to pay 75% of school tuition.
- In case of an early withdrawal with outstanding tuition or fees, school records will not be released or transferred, nor will academic credit be granted, until the account is paid in full.

## TUITION AND FEES REFUND POLICY

- Application and enrollment fees are non-refundable.
- If a student withdraws early, tuition will only be refunded for remaining **full** quarters not attended.
- If a student decides to stop riding the bus after the first day of a semester, bus fee will not be refunded.
- In case a student ceases from attending school without following a formal withdraw procedure, no refund will be given for the days not attended.
- No portion of tuition shall be refunded for a student dismissed by expulsion or for disciplinary reasons.
